- 1. Eligibility Criteria:** Quotation forms will be issued to contractors who qualify in the following criteria:
 - a. Agency specialized in similar nature of work can apply. Copies of valid Licence/Registration shall be submitted.
 - b. Contractor shall have satisfactorily completed (Phase / Part completion of the scope of the work in a contract shall not be considered.) at least three works each of Rs.1,20,000/- or two works each of Rs.1,50,000/- or one work of Rs.2,40,000/- of such works during the last seven years ending on 30th September 2018. As a proof of above, Contractor shall submit Work completion certificate / experience certificate mentioning the date of completion of work. Contractors producing certificate from Non - Govt. / Non PSU organizations should also submit "Tax deduction at source certificate" in support of their claim of having experience of stipulated value of works.
 - c. Contractors shall have annualized average financial turnover of atleast Rs.90,000/- against works executed by it during last three financial years ending on 31/03/17. CA Certificate shall be submitted as a proof.
 - d. Contractor shall submit copy of its GST Registration and PAN Card.
 - e. Consortiums/Joint venture companies shall not be permitted.
- 2. Schedule:**
 - a. Application for issue of Quotation Form shall be submitted upto 1700 hrs. of 30/10/2018 on all working days. The application shall be supported with self-attested copies of the documents mentioned in eligibility criteria.
