1. **Eligibility Criteria:** Quotation forms will be issued to contractors who qualify in the following criteria:

- Contractor shall be enlisted Civil contractor of CPWD /P&T /State PWD/Rly./MES /PSUs in such works. Copies of valid Licence of Contractor Registration shall be submitted, as applicable.
- Contractor shall have satisfactorily completed (Phase / Part completion of the scope of the work in a contract shall not be considered.) at least three works each of Rs.1,14,238/- or two works each of Rs.1,42,797/- or one work of Rs.2,28,475/- of civil works during the last seven years ending on 30th November 2018. As a proof of above, Contractor shall submit Work completion certificate / experience certificate mentioning the date of completion of work. Contractors producing certificate from Non - Govt. / Non PSU organizations should also submit "Tax deduction at source certificate" in support of their claim of having experience of stipulated value of works.
- Contractors shall have annualized average financial turnover of atleast Rs.85,678/- against works executed by it during last three financial years ending on 31/03/17. CA Certificate shall be submitted as a proof.
- Contractor shall submit copy of its GST Registration and PAN Card.
- Consortiums/Joint venture companies shall not be permitted.

2. **Schedule:**

- Application for issue of Quotation Form shall be submitted upto 1700 hrs. of 10/12/2018 on all working days. The application shall be supported with self-attested copies of the documents mentioned in eligibility criteria.
- Quotation forms will be issued to eligible applicants from 11/12/2018 to 13/12/2018 and received till 1430 hrs. of 14/12/2018 and opened (tentatively) on the same day at 1500 hrs.

- Original documents shall be produced for verification before issue of quotation.
