### Terms & Condition:

1. Agency will be appointed to prepare Grid Map for Airport Vicinity of DBAI Airport, Nagpur, as per DGCA Aerodrome Advisory Circular 07 of 2017.
2. Complete contact details viz Address, Phone no. and E-mail ID shall be clearly mentioned on the application. The application shall be supported with self attested copies of the documents mentioned in eligibility criteria.
3. **Rates shall be quoted in schedule 'A' attached herewith.** Special care shall be taken to write rates in figures as well as in words in such a way that interpolation is not possible. The total amount shall be written in both figures and in words. In case of ambiguity in them, rates mentioned in words will be only considered.
4. Quotations, which should always be placed in sealed covers under-scribing the name of work and contact details, shall be received upto **1500 hours** on 18/03/2019 and shall be opened (Tentatively) at **1530 hours** on the same day.
5. **Eligibility Criteria:**
  - a. Valid Registration of Firm.
  - b. PAN Card.
  - c. Valid Registration Certificates of GST.
  - d. Consortiums/JV shall not be permitted

- e. Company/firm/agency shall have satisfactorily completed (Phase / Part completion of the scope of the work in a contract shall not be considered.) Similar work/s pertaining to "Preparing Grid Map of Airport" for at least 01 Airport, during last Seven years ending on 28<sup>th</sup> Feb, 2019. As a proof of above, Company/firm/agency shall submit Work completion certificate/experience certificate mentioning the date of completion of work. Company/firm/agency producing certificate from Non-Government / Non PSU organization should submit 'Tax Deduction at Source certificate in support of their claim for having experience of stipulated value of works.
6. If directed by MIL, Original documents shall be produced for verification.
7. If any document is not applicable undertaking mentioning the justification shall be submitted. Non-submission of any document will be liable for disqualification.
8. Payment will be done on satisfactory completion of work order.
9. **Submittals:** Detailed Grid Map as per DGCA Aerodrome Advisory Circular 07 of 2017, to be prepared. Grid Map of Airport Vicinity should include surrounding communities and depict appropriate medical facilities, access roads, rendezvous point etc., within a distance of approximately 8 Kms. from the centre of the Aerodrome i.e ARP point. Grid Map to be submitted in hard and soft copy (AutoCAD and PDF).
10. Proper nomenclature/identification etc., of the installation (Hospital/Police Station Etc.), is to be used while preparing the Grid Map.
11. Period of completion of the individual work is 45 (Forty Five) Days which shall be reckoned from the date of placing the work order. If the appointed agency fails to complete the work within the stipulated period and no justifiable reasons are found for the delay, agency shall be liable to pay the compensation for delay at the rate of one percent of the total value of work order. The amount of compensation for delay or waived of compensation delay in case of justified reasons shall be decided at the discretion of competent Authority and same shall be final and binding to the appointed agency.
